In the amendment procedure of **CZECH-HUNGARIAN BUSINESS CLUB" Association**(seat: 1142 Budapest, Erzsébet királyné útja 125.), the Metropolitan Court of Győr issued the following

Simultaneously, the court establishes that the representation right of Balázs Dalnoki has been terminated.

This resolution is not open for appeal.

The prosecutor or anyone concerned – with regard to the part that concerns them – may file a lawsuit against the association to repeal the resolution on grounds that the resolution, the procedure it was based on or the documents submitted are against the law.

The lawsuit shall be filed at the metropolitan court competent for the seat of the association within 60 days after the publication in the national register. The right to file the lawsuit shall be forfeited upon expiry of the above time limit.

EXPLANATION

The association – via its legal representative – announced to the court of registry that the supreme body of the association has modified its bylaws, elected new representatives, specified the type and method of representation rights, clarified the name of the association, set the foreign names of the association, therefore asked to register the above changes.

The attachments of the request met the requirements of Act V. of 2013 on Civil Code (Ptk.), Act CLXXV. of 2011 (Ectv.) and Act CLXXXI of 2011 (Cnytv.) therefore the court registers the changes.

The court waives the detailed explanation of the resolution with regard to Section 5 Article 1 of Cnytv. and Section 347 Article 1 of Act on civil procedures.

Provisions in Article 1 to 3 of Section 46/A of Cnyt. exclude the right to appeal and provide for the possibility of filing a lawsuit.

When filing the lawsuit, the claimant shall specify the reasons why the court's procedure was unlawful.

The court calls the attention of the legal representative to the fact that any amendment of the registered data shall be announced to the court within 60 days upon the resolution of the supreme body. Should the request contain information based on which it can be established that the association failed to meet the above deadline, the court may impose a fine between HUF 10.000 and 900.000 on the association.
